Section 4 – This act shall take effect immediately upon passage.



Section 4 – This act shall take effect immediately upon passage.





PURPOSE: This bill reflects the requests put forth by the Criminal Law Society and Women's Rugby for additional funding to supplement their allocations from Fall 2023 Bill No. 13 and the request of the Student Wellness Society (SWELL) for funding for a General Interest Meeting.

BILL TEXT:

Section 1 – Pursuant Article III of the Student Bar Association Constitution and Bylaws Ten and Eleven of the Student Bar Association Bylaws, the Student Bar Association shall provide additional funding to prior allocations and funding for a new club General Interest Meeting, with funding to come from Fall 2023 Resolution 1:

- ii. Jeopardy TOTAL: \$24.00

(b) Women's Rugby Club - TOTAL GRANTED: \$125.00

- ii. Game and Social with Barracks Rangers TOTAL: \$75.00


(c) Student Wellness Society – TOTAL GRANTED: \$60.00




