# i. Event and Funding Request Breakdown:

- 1. Fundraising/Tabling, \$65.92: This event will be happening throughout DEI week and Gender in the Law Week which is occurring March 25, 2024 March 29th, 2024. This year, instead of doing a fundraising event, as we did during Fall 2022 at the Yard, we want to do a tabling in front of the library on a cause. Some ideas we have for the cause are the Legal Project DV Clinic, Unity House, or Urban Grief.
  - **a.** The organization is voting on the cause that the fundraising would go to; need to make the baskets for the fundraiser.

# m. Men's Rugby

# i. Event and Funding Request Breakdown:

- 1. 35<sup>th</sup> Annual William Watkins Memorial Tournament, \$8,089: budget is on behalf of both the Men's and Women's Rugby team. Both E-Boards have worked together to plan the event, and we will be hosting the event together. April 20th, 2024 from 9am to 7pm. The tournament will be held on both the pharmacy school field and Dick Green field. We are expecting 300 total attendees between students, alumni, other teams, and spectators. We had approximately 175 people last year and are increasing the team count significantly. This will now be a 14 game tournament between the men's and women's teams playing. The alumni attendance will also be much higher because they are holding the induction for the first Blue Jackets Ceremony. We understand that we are asking for a lot of money, however, the reason we are asking for so much is because of the amount of people expected to attend.

# n. Women's Rugby

# i. Event and Funding Request Breakdown:

- 1. GIM, \$60: The GIM will be a great way for students to see what our team is all about and hopefully decide to join us. Rugby is a great way to get exercise and build lasting friendships that will be helpful in both our personal and professional lives
- 2. Women's Ruby Alumni Networking Night, \$300: This event will be open to the entire school, but we specifically encourage women to come to this event to meet some great female role models. These amazing role models are Albany law alumni who also played rugby while they were students. # q. SWell

## i. Event and Funding Request Breakdown:

# s. Hockey Club

# i. Event and Funding Request Breakdown:

- 1. Funding for Ice Time, \$400: The hockey club plays several games each semester against fellow local, informal hockey organizations, for which the club members who skate in the games pay out-of-pocket. We are requesting that for each game we play, SBA fund \$100 of the cost to rent the ice and pay the referees. We plan on scheduling at least 4 games, so this will mitigate some of the ice time costs we are going to incur.
- 2. Floor Hockey Event, \$123- amended to request \$175: This floor hockey event will contribute to the social lives of students because it will allow students to engage in the sport of hockey, on the gym floor rather than on the ice, where an inability to ice skate does not bar one from playing. We attempted to hold this event last semester, but we were unable to secure the gym on a Saturday that would have worked with our schedule.
  - **a.** Would prefer to move ice time funding to the floor hockey event and would cover ice time out of pocket in order to have people feel welcome and come play hockey; maybe move \$100 out from the ice time
- **3.** GIM, \$60: This event contributes to the intellectual and social lives of our fellow students because it gives students of Albany Law an opportunity to join a student organization of like-minded individuals who love ice hockey and/or are interested in playing hockey.

### t. Federalist Society

### i. Event and Funding Request Breakdown:

1. Careers in the NYS Solicitor General's Office, \$88.50: This event will expose students to a career path that is not often, if at all, discussed throughout law school.

# u. Sports and Entertainment Law

- 1. GIM, \$60: The general interest meeting will inform members (and all students) about the events for this semester to get those interested in sports and entertainment law engaged in the field. It provides a space where students can engage with individuals with similar interests while advancing their legal career goals.

- **3.** Outing to a local sports game, \$200: Attending a local sports game will foster strong community relations between Albany Law students. It provides a fun activity related to the practice of the organization, can create meaningful relationships, and impact students mood/social life.
  - **a.** Suggestion from Senate to attend hockey and ALS sports events instead of the lacrosse Fire wolves game

# i. Event and Funding Request Breakdown:

- 1. GIM, \$60: Fostering networking and information exchange
- **2.** International Law Careers Panel and Networking, \$200: Networking and learning about international career options
- **3.** International Human Rights Panel, \$200: Allows students to learn more about what can be done in the legal profession to help combat international human rights violations.

### w. Bell Collective

# i. Event and Funding Request Breakdown:

- 1. The Speaker Series, \$86.17: The Speaker Series will provide Bell Collective members and non-members to build a sense of community and belonging, allowing for intimate conversations with legal professionals about race, identity, and their experiences within the legal field.
- 2. Tabling for CRT Symposium, \$9.36: 3/1/24 12 PM Outside of Library. This is promote the CRT Symposium later that month, increase attendees, and increase overall membership.
- 3. 3<sup>rd</sup> Annual CRT Dialogue Symposium, \$1,001.95: The purpose of this dialogue is to foster cultural competency in our law school environment and to create awareness of racial/ethnic challenges and implications in the legal profession. Our symposium will not only provide cultural awareness to practitioners, but it will provide them with skills around cultural competency, and how to interact and serve clients.
  - a. 3 law firms are sponsoring and attending as well as some out of state and outside speaker come to the event again; encourages senators to come to the events

### x. LALSA

- 1. GIM, \$63: The purpose of this event is to spread awareness to current and prospective members about our upcoming events and/or how to get involved with our organization.
- **2.** Heritage Dinner, \$1,355.82: The annual Heritage Dinner brings together students and is a chance to cover the impact of legal issues on the Latino community.

- **a.** Taking out flowers and vases is fine; a cultural "gala" and the awards for higher status judges/people. This event is open to everyone, but recognizing Latino alumni.
- **3.** Finals Coffee, \$451.44: This event provides a chance for students to take a break during finals, eat, and converse with some people in the ALS community.
- 4. Valentines Day Goodie Bags, \$86: 2/13/24, 12 PM, Cafeteria/Library- This is to provide Valentine's Day gifts available for the ALS community.

# i. Event and Funding Request Breakdown:

- 1. Trademark Registration Workshop, \$50: We had a copyright workshop and a patent workshop in the fall and they were successful events. We would like to hold a trademark workshop to show students how the third main area of intellectual property law works and the intricacies that come along with registration.
- 2. IP Trivia, \$50: we held this event last year and it was our most successful event. It's not just a random trivia night, like I've been to with other groups, but this trivia is specifically IP questions that helps students learn about all the different intellectual property areas.

#### z. First Gen Law Students

### i. Event and Funding Request Breakdown:

- 1. First Gen Law Panel, \$337.15: This event would encompass allowing first-generation law students the chance to network with already established lawyers. FGLSA would contact attorneys within the area along with faculty and have an event with several attorneys where students can sit down and speak with established lawyers & ask any questions about their experience and career.
- 2. 2L Registration Preview, \$139.33: This Event would be similar to the registration event many of us had during our first semester of 2L. We wanted to make this event this semester because, while the registration event hosted by the school was extremely helpful, we wanted to give the students this amazing opportunity before they created their first schedule on their own. Additionally, we plan to partner with the DLC (Disabled Lawyers Coalition) for a lecture on getting accommodation services for the spring 2024 and subsequent semesters.

#### aa. NLSA

- 1. GIM, \$60: -
- 2. Meet and Mingle-Public Sector Guests, \$500: This event is a early semester check-in and will include informal networking with attorneys actively working within the public sector. It will enhance

- networking among non-traditional law school students who have unique challenges, needs, and opportunities that require a different type of conversation, venue, and support system.
- 3. Meet and Mingle Private Sector, \$500: This event is a late semester conclusion event and will include informal networking with attorneys actively working within the private sector. It will enhance networking among non-traditional law school students who have unique challenges, needs, and opportunities that require a different type of conversation, venue, and support system.
  - a. Asks to fund both but in half instead of one or the other
- 4. Professional Panel of Attorneys and Networking, \$1,980: The NTLSA "flagship" panel event comprised of law graduates of ALS and other institutions who were non-traditional during their time in law school. Panelists will include individuals in private and public sector roles, not limited to practicing attorneys. The panel will focus on addressing the unique challenges faced by non-traditional students, the employment application process, and allow for network building within the non traditional Albany Law School community. Panelists will predominately be located in the capital region.

# i. Event and Funding Request Breakdown:

- 1. Western New England Law School Basketball Tournament, \$1,265: Tournament has a networking mixer event that allows students to meet and network with their peers from other law schools in the area.

# i. Event and Funding Request Breakdown:

### 1. 3L Senate:

**a.** Farewell Party, \$20,000: This money will pay the remaining balance on the vendor, pay the tip for the DJ and photographer, and pay for decorations at the event.

- b. Mentorship Program Mixer, \$500: We had this event last semester and it was a great success! We had 40 attendees, mentors and mentees, and the amount of funding that we received (\$400) was sufficient to pay for dinner (no leftovers of Cardonnas catering). This semester, the 3L Senate is partnering with the 1L Senate and the Spring Start Senator to increase participation and to welcome the new spring starts to the program.
  - i. Totally okay with the \$400 proposed by the finance committee.
- c. 3L Tabling for class gift, commencement, and bar prep, \$500: The 3L Senate is planning to hold a tabling event in February to hand out brochures that list the necessary requirements for admission to the bar in NYS and ice cream (the ice cream makes sense when you see the flyer).

It will build on the community aspect by bringing students together, especially those in different sections or those who have opposite schedules. Students and staff will have the opportunity to meet each other and network.

# gg. SBA Entity

### i. Event and Funding Request Breakdown:

1. Spring Finance Budget Meeting, \$27.48: This contributes to the life of the law school because this ensures that the committee members volunteering their time to assist SBA with the budget process are adequately fed for their time.

- 2. SBA Budget Meeting, \$528.25, amended to \$514.25: Expecting 26 Senator attendees and nearly 40 student organizations to attend. This contributes to the life of the law school because it ensures that the students who are volunteering to assist with allocating student activity fee funds are adequately fed throughout the day.
- **3.** Gift Cards, \$75: This is a required expenditure pursuant to the SBA Bylaws. SBA is required to host a survey to assess the engagement of the student body each semester among other things. Therefore, this boosts the participation in our survey with an incentive for better data.
- **4.** Flash drive, \$23.99: This contributes to Albany Law School in the long run because, over the last 10 years, we have lost much documentation and institutional knowledge from subsequent Executive Boards. This flash drive will be past down between Executive Boards and contain all necessary files for their success.
- **5.** Toner Replacement Cartridge, \$39.99: SBA owns a printer in the SBA Office. To ensure free printing services are available for student events and activities, we will need to ensure there is available toner replacements.

# i. Event and Funding Request Breakdown:

- **1.** Diversity Committee:
  - **a.** The 16<sup>th</sup> Annual Multicultural Cabaret, \$2,321.69: The Multicultural Cabaret is an annual event at ALS that brings together various cultures and traditions. The event creates a social and fun atmosphere where students and faculty enjoy food, music, performances and drinks.

# IV. STATE OF THE BUDGET

# a. The money that we have:

- i. Currently in account (not including money earmarked from Fall 2023 for Barristers' and Farewell): ~\$96,326.45
- ii. Money we need to keep for future use (cannot spend): \$20,000.00
- iii. Money being allocated for emergency funding & appeals and new student orgs for GIMs per SBA Resolution #4: \$1,800.00
- iv. Money we have available to allocate for this semester's events and items: ~\$75,000.00
- v. However, full allocation, if everything is spent, would mean the Senate would only have ~\$45,000 to spend next fall. Allocating \$60.5k would mean the Senate would have \$60.5k to allocate next semester. Additionally, even though we allocated about \$71,000 last semester, organizations spent a little over \$61,000 per the Fall 2023 Financial Report. As such, it is strongly recommended to allocate only ~\$60,500.00.

# b. The money being requested:

- i. Clubs and organizations are requesting a total of \$46,453.12
- ii. SBA as an entity, the committees, class senates, and at-large senators are requesting a total of \$34,997.69
- iii. Total being requested for Spring 2024: \$81,450.81
